Financial Report on the position of the Association from PR Accounting

CEO Notes:

Revenue - Though membership slowly grows we are not getting the penetration we need in the wider fringe markets.

Revenue - Silvercard Forklift Training is developed to assist the revenue stream of the Association in creating the guidance and safety awareness/improvement campaigns. This has not got realised its potential yet.

Expenses - Administration is the fee we pay HIANZ to run our admin team and the expenses around the GPG build.

Expenses- Silvercard, this is the development costs associated with getting the course built, moderated and signed off by the WDC and Competenz.

Expenses - Website - this is the operation of our existing site and some of the cost of the construction of our new site, hopefully up and running in the next month.

Net loss before tax = \$107,286.00 FY. This is all sitting as a debt only with HIANZ. No other creditor is owed anything.

Balance sheet:

Current Assets - Prepayments is the figure being forwarded into the new financial year for training program build.

Liabilities - Creditors - This is all to HIANZ. The are financially supporting the build and implementation of our training program.

Retained earnings show us in negative position of \$108296.00.

Motion:

That rule 22 of the New Zealand Forklift Industry Association Inc. rules (constitution) be enacted as follows and the Association is merged into the Hire Industry Association of NZ Inc. (HIANZ) and the affairs of the association are wound up, distributing all assts to HIANZ.

Rule 22 Liquidation

22.1 The Association may be put into liquidation in the manner provided by section 24 or section 25 of the Act.

22.2 Upon such liquidation, the assets of the association shall, after payment of all liabilities, be disposed of in such manner as the members shall determine, provided that they shall not be divided amongst the members but shall be distributed amongst some body or bodies having similar aims to those of the association.

Reason for this Motion:

1. Despite facing challenges over the past five years, NZFIA has remained resilient and focused on its mission. With limited financial resources, the dedication and commitment of our members have kept us moving forward. While growth opportunities may have been scarce, we have continued to advocate for our industry.
